PROPOSED AMENDMENTS TO ARTICLES OF ASSOCIATION

The Board hereby announces that the resolution in relation to the proposed amendments to the Articles of Association has been passed at a meeting of the Board held on 27 October 2017. The Proposed Amendments are subject to the approval by the shareholders at the general meeting of the Bank by way of a special resolution as well as the approval by the China Banking Regulatory Commission Heilongjiang Bureau.

A circular of the Bank containing detailed information of the Proposed Amendments will be dispatched to the shareholders in due course.

The board of directors of Harbin Bank Co., Ltd. (the “**Bank**”) (the “**Board**”) hereby announces that pursuant to the principles and relevant requirements as set out in the official documents including the *Guiding Opinions on Deepening the Reform of State-owned Enterprises* (《關於深化國有企業改革的指導意見》), the *Certain Opinions on Upholding the Party's Leadership and Strengthening the Party Construction in Deepening the Reform of State-owned Enterprises* (《關於在深化國有企業改革中堅持黨的領導加強黨的建設的若干意見》) and the *Notice regarding the Promotion of the Incorporation of Party Building Works into the Articles of Associations of State-owned Enterprises* (《關於扎實推動國有企業黨建工作要求寫入公司章程的通知》), the Bank proposed to make relevant amendments (the “**Proposed Amendments**”) to the Articles of Association of Harbin Bank Co., Ltd. which are currently in effect, the Articles of Association of Harbin Bank Co., Ltd. (Draft Version) which will come into effect after the listing of the A shares, the Articles of Association of Harbin Bank Co., Ltd. (Draft Version) which will come into effect after the issuance of preference shares, and the Articles of Association of Harbin Bank Co., Ltd. (Draft Version) which will come into effect after the issuance of preference shares and the listing of A shares (hereinafter referred to the “**Articles of Association**”, collectively).
